

GENERAL CONDITIONS: I do hereby agree that I shall appear at all times and places as ordered by the Court or ordered by a Court where this charge may be prosecuted. Further, I shall appear for trial; and, if convicted, appear for sentencing and execution of sentence. I will obey all Orders of the Court and comply with any conditions the Court may impose, including but not limited to those listed herein. I agree that it is my duty to keep in close contact with my attorney, including keeping my attorney advised of my current address and telephone number so that I can be advised of my court dates. I further agree it is my duty to keep the Court advised of my whereabouts at all times; I shall notify the Court prior to any change of address and shall not leave the State of Oregon without permission from the Court.

VIOLATION OF CONDITIONS: I am further instructed that a warrant for my arrest will be issued immediately upon any violation of a condition of this release. Any violation of these conditions shall subject me to revocation of this release, and order of detention, and prosecution for Contempt of Court punishable by up to six months in jail and/or a \$500.00 fine.

FAILURE TO APPEAR: For any failure to appear as required before a judge or other judicial officer, a warrant for my arrest may be issued, and I may be subjected to prosecution on the additional charge of Failure to Appear under the following penalties: Forfeiture of Security; if felony charge, a fine of not more than \$125,000 and imprisonment for not more than five (5) years; if a misdemeanor charge, a fine of not more than \$6,250 and imprisonment of not more than one (1) year.

9 The defendant having been charged with the crime(s) of CRIMINAL MISCHIEF IN THE
10 SECOND DEGREE herein, and the District Attorney having determined that it is appropriate to
11 propose a Diversion Agreement pursuant to ORS 135.881 et. seq., and the defendant having agreed to the
12 terms of that agreement, now, therefore, the parties do acknowledge and agree as follows:

13 1. MANDATORY TERMS

14 A. Duration of the Diversion Period

15 The diversion period shall be 180 days from and after the date of this agreement. The
16 termination date of the agreement shall be as indicated on the last page of this
17 agreement.

18 B. Waiver of Speedy Trial.

19 Defendant has been fully advised of the right to a speedy trial in this matter. Defendant
20 freely, knowingly and voluntarily waives that right during the period of diversion.

21 C. No Law Violations.

22 During the period of diversion the Defendant shall violate no federal, state or municipal
23 law or ordinance, minor traffic violations accepted.

24 D. Admission of Guilt, Waiver of Jury and Stipulation.

25 Defendant hereby acknowledges that defendant is guilty of the crime(s) charged in this
26 matter. If this matter should ever come to trial, defendant hereby irrevocably waives
trial by jury and agrees that trial may be had by the Court alone. Defendant hereby
stipulates that in any such trial the State of Oregon can prove each and every element of

1 the crime(s) charged beyond a reasonable doubt and to a moral certainty and that this
2 stipulation may be received as evidence at trial.

3 E. Release Agreement.

4 Defendant shall forthwith contact the Trial Court Administrator's office to execute any
5 requested new release agreements. During the period of diversion all of the terms of
6 Defendant's release agreement shall be in full force and effect. It is Defendant's
7 responsibility to comply with all terms of the release agreement including advising the
8 Trial Court Administrator's Office of any changes in Defendant's address.

9 F. Verification of Compliance

10 Defendant understands that it is the sole responsibility of Defendant to complete all of
11 the terms of this agreement and to submit adequate proof of such completion to the
12 District Attorney's Office in a timely manner. The District Attorney may, but is not
13 required to, independently verify completion of any term. If Defendant fails to provide
14 the District Attorney with adequate proof of successful completion, the District
15 Attorney will be justified in revoking this agreement pursuant to paragraph 1G below
16 notwithstanding the fact that Defendant may have actually successfully completed the
17 term in question.

18 G. Revocation of Agreement
