

- Demand a jury trial and pay the fee required (below). This option is available **only** if the amount claimed is more than \$750.

If you fail to do one of the above things within **14 DAYS*** after you get this notice, the plaintiff may ask the court to enter of judgment against you. The judgment will be for the amount of the claim, plus filing fees and services costs paid by the plaintiff, plus a prevailing party fee. If you are not able to respond in time because you are in active military service of the United States, talk to a legal advisor about the Servicemembers Civil Relief Act.
